Epidemiology

Epidemiological comments
There have been no new outbreaks of highly pathogenic avian influenza since the outbreak reported in the immediate notification report on 18 May 2006.
All investigations conducted in the protection and surveillance zones (clinical inspections and laboratory analyses) showed no evidence that the disease had spread from the infected farm. In compliance with European Union legislation, the protection and surveillance zones were lifted on 30 June 2006.
The Danish Veterinary and Food Administration considers that the event is resolved. As a result, and in compliance with European Union legislation, all local restrictions have been lifted. It is expected that Denmark will comply with the requirements of Article 2.7.12.4. of the Terrestrial Animal Health Code on 29 August 2006.
