Epidemiology

Epidemiological comments
Vaccination was not resorted to although it was considered initially.

To date, no further cases of avian influenza have been reported from this area or from any other part of the country.

More specimens, collected during stamping out, have been referred to the diagnostic laboratory.

Although falling under two different administrative divisions (States), the episode is considered as one single outbreak as the infected zone in both administrative divisions falls within a 3-km radius of the infected premises.

Compensation is being paid to poultry owners whose birds were destroyed in containment operations.

To date no human case of AI has been detected.
